Minimum cumulative GPA of 3.25, and enrolled in at least 6 credit hours. Must have a declared Major in the College of Business, preference will be given to Sophomores.
Adkisson, Richard & Justine Endowed Scholarship	Sophomore, Junior, or Seniors w/ a minimum GPA of 3.25. Must have a declared major in the Department of Economics, Applied Statistics, and International Business.

Allen, Johnna Christine: Memorial Scholarship. Donated by friends of the Allen family	Preference to one female student, and to U.S. Citizens. Scholarship may vary in amount. Sophomore or higher; 3.0 GPA; U.S. citizen; full-time student in College of Business.
Allred, Lynn: Memorial Scholarship. Established by Everett Crawford, Citizens Bank, and its employees	Preference to females and U.S. citizens; 2.5 GPA; demonstrates financial need; returning student. Preference given to business major. Selected by the Scholarship Coordinator in the Financial Aid Office.
Alvarez Family, Brenda and Joe: Endowed Scholarship.	Awarded to Juniors or Seniors with 3.0+ GPA; must be a graduate of a New Mexico high school; declared major in COB; full-time student; preference shall be given to Hispanic students.
American Society of Women Accountants (ASWA).	Varying amount awarded not to exceed \$650.00 to undergraduate Accounting major with 3.0 GPA ; U.S. citizen or eligible non- citizen. Must have completed ACCT 221 or its equivalent (Financial Accounting).

Barham Family: Centennial Scholarship. Established by David, Hugh, and Julia Barham	Varying amount for a student in the COB who is a U.S. citizen and who has a 3.0 or higher cumulative GPA; student should be enrolled in ROTC; preference given to Freshmen.
Barham, David: Memorial Centennial Scholarship.	Sophomore/Junior/Senior; U.S. citizen; 2.75 GPA; student must be working part-time.
Barham, Hugh F., Julia, and Forrest J.: Centennial Scholarship. Established by Hugh F. Barham	Varying amount to a Freshman with a cumulative GPA of 3.0 or better. Recipient must be a U.S. citizen; No financial need required.
Beasley, Don Endowed	Must be a junior or senior; declared a major in Accounting w/ a 3.25 GPA; preference will be given to a student who plans to pursue a master's degree in accounting w/ NMSU, and plans to practice accounting in the state of New Mexico as evidenced by a statement of professional and career goals.
