MAP REQUIREMENTS

Once you have completed 60 credit hours, you can apply to the Master's Accelerated Program

- Juniors must have an undergraduate GPA of 3.75 (cum) or higher and Seniors must have an undergraduate GPA of 3.50 (cum).
- During your junior or senior year, you can enroll in 500 Level MBA courses.
- Graduate courses must be passed with a B or higher in order to count as graduate degree credit. *NOTE: MAP courses completed with lower than a B are not eligible for graduate credit.*
- Up to 12 hours of coursework can be applied toward the completion of the MBA.
- For tuition purposes, students will be considered undergraduates until they complete their undergraduate requirements. Once accepted to a Master's Accelerated Program at the junior or senior year, students will continue to be charged tuition and fees at the undergraduate rate and retain eligibility for undergraduate scholarships. Contact your financial aid advisor to discuss federal aid eligibility.
- Students must meet all application deadlines and program requirements in their undergraduate and graduate programs.

Qualifications and Background Knowledge for the MAP/MBA program

Juniors or Seniors may participate in this program if they have completed the following courses with grades of B or higher in each course:

- ACCT 2110, **Principles of Accounting I** (formerly ACCT 221)
- ACCT 2120, **Principles of Accounting II** (formerly ACCT 222)
- ECON 2110G, **Macroeconomic Principles** (formerly ECON 251G)
- BFIN 341, **Financial Analysis and Markets** (formerly FIN 341)
- MATH 1430G, **Applications of Calculus I** (formerly MATH 142G) or equivalent
- MATH 1350G, **Statistics** (formerly STAT 251G/ A STAT 251G) or equivalent

HOW TO APPLY

Students may complete four MBA courses while they are still undergraduates and may count those courses toward both their undergraduate degree and the MBA.

ELIGIBLE MBA COURSES

MBA classes are offered on main campus in the evening (6:00 pm - 8:30 pm) one night per week
(with courses scheduled Monday through Thursday)

- ACCT 503 Managerial Accounting
- BCIS 502 Business Information Systems (ask MBA advisor about cross listed courses UG/GR)
- ECON 503 Management Economics (Can count for the UD ECON elective in the UD core for the BBA and the MBA)
- BFIN 503 Financial Management (ask MBA advisor about cross listed courses UG/GR)
- BLAW 502 Legal Enviro of Business (Can count for BLAW 316 in the UD core for the BBA and the MBA)
- MGMT 502 Operations Management
- MGMT 503 Organizational Behavior & Management Processes
- MKTG 503 Marketing Management
